#### Responsibilities

PWG members are expected to complete the following tasks:

- Promote the Call for Proposals and Call for Reviewers October/November 2019
- Participate in PWG kick-off conference call November/December 2019
- Review sessions in the first round of review for Greenbuild Mexico November/ December 2019
- Participate in the PWG pre-retreat preparation conference call December 2019
- Review approx. 30-35 proposals in preparation for the Program Working Group Retreat -January 2020
- Attend the mandatory in-person Greenbuild Program Retreat January 15, 2020, Mexico City, Mexico
  - Select complete 60-minute sessions from those submitted through the Call for Proposals
  - Identify key topic area holes in the program and help develop invited sessions to fill those
  - Identify commonality in accepted sessions and develop Greenbuild Tracks
- Attend Greenbuild Mexico 2020 June 24-25, 2020
