Online submission of abstracts opened on October 17, 2017 and closes on January 10, 2018 at 11:59 p.m. Pacific Time. <u>www.tinyurl.com/2018IID</u>

RULES AND REGULATIONS

Only one paper or poster may be read or presented by the same author at the Meeting, although a presenter may be a co-author of any number of papers. The material must not have been published prior to submission of the abstract or presented at any meeting prior to the date of presentation at the International Investigative Dermatology 2018 meeting. Simultaneous submission of the same abstract to other meetings is prohibited.

There is a limit of **2,300** characters for the text of your abstract submission (title, authors, institutions, abstract body and all spaces will be counted).

PUBLICATION OF ABSTRACTS

All abstracts will be published in the May 2018 issues of the Journal of Investigative Dermatology (JID) and Journal of Dermatological Sciences (JDS). The abstracts will also be available via links on the SID, ESDR and JSID websites approximately mid April 2018. Hard copies of the Program Book will be available at the meeting.

Abstract acceptance notification will be sent the week of February 12, 2018.

ABSTRACT FEE

The publication/processing fee is \$50 US and must be paid via the internet at the time of submission.

PRESENTATION

The IID 2018 Scientific Program Committee reviews all abstracts without knowing the identity of authors. All abstracts, including those selected for oral presentation, must be presented as posters.

NOTES ABOUT 2018 ABSTRACTS

- Unless indicated by initiating an opt-out, all abstract submissions to the 2018 Meeting will be considered for Oral Presentation.
- Submitters must choose both a primary category for their abstract, as well as a secondary category. Doing so will help the Scientific Program Committee have the flexibility (if needed) to put together the best possible meeting program.
- An electronic poster viewing system will be available as a companion piece to physical posters. Updates will be posted as they become available on the IID website.

TRAVEL FELLOWSHIP AWARDS

The Society for Investigative Dermatology (SID), European Society for Dermatologic Research (ESDR), and the Japanese Society for Investigative Dermatology (JSID), will be providing travel grants to offset costs associated with attending the IID 2018 Meeting in Orlando, Florida (May 16-19, 2018). Abstract Title

Enter the title with the first letter of the first word capitalized. All other letters are to be in lower case.

• Presentation Type

All submitted abstracts will be considered for oral presentation unless otherwise indicated in the presentation type drop down

TASK 1 – AUTHORS

In this task, you will create the list of presenters for this submission. You will also complete the author's profile.

TASK 2 – ABSTRACT BODY

This task includes choosing your first and second preferred abstract categories and entering the abstract body. Click <u>here</u> to view the IID 2018 Abstract Categories.

TASK 3 – KEYWORDS

In this task, you will select up to three keywords. You are required to select at least one keyword. You will also have the opportunity to enter in an optional, freeform keyword if your keyword was not found in the list.

TASK 4 – TRAVEL AWARD APPLICATION

If eligible, please fill out the application and upload it to the submission. *This is a required task* - if you do not wish to apply or are not eligible for this award, please click on the task and select, *'I have nothing to upload for this submission.'*

TASK 5 – ABSTRACT DISCLOSURE/ OPTIONAL PROGRAMS/ PRIMARY ORGANIZATION AFFILIATION

This task includes completing a disclosure on Identifying Products and Discussing Unlabeled Uses of Products, indicating your interest in an Academic-Industry Partnership, willingness to allow your abstract to be considered for presentation at an associate meeting, and selecting the presenting author's primary organization affiliation (SID, ESDR, JSID or other).

TASK 6 – PAYMENT

Complete the payment task to pay for your abstract submission.

When you have completed all tasks successfully, you will then click the Submit button. You will have until January 10, 2018 at 11:59 p.m. Pacific Time (US) to make any changes to your abstract submission.
