Plant Biology 2021 is a meeting of the American Society of Plant Biologists. The conference will feature four plenary symposia, large poster sessions, 28 concurrent symposia, and select 2-minute Rapid Communication talks comprised primarily of speakers selected by the Program Committee from submitted abstracts.

Abstracts should be submitted in the provided text box in the step-by-step abstract submission process. Submissions cannot be over 300 words and may not include any graphics or tabular material. You do not have to be an ASPB member to submit an abstract.

Please note that a \$25.00 non-refundable abstract submission fee is required for each abstract submission. A payment confirmation code, obtained once the abstract fee has been paid, will be required at the beginning of the submission process. All presenters must register to attend the meeting. ## EDIT VIRTUAL AGREEMENT TASK FOR 'TEST1'

Please read the statement below

I ("Presenter") agree to make a live streamed or pre-recorded oral presentation ("Presentation"), and/or a pre-recorded poster presentation ("Poster"), as selected by the program committee, at ASPB's Plant Biology 2021 Worldwide Summit. In exchange for being permitted to make my Presentation at the Event and the benefits derived from my Event participation, as well as other good and valuable consideration, I hereby knowingly and voluntarily execute this Presenter Agreement:

1. Release and Consent. Presenter acknowledges and grants consent for ASPB to live stream and/or record the Presentation through various means, including live online audiovisual feed, video, photograph, and audio recording. For a period of one (1) year from the Conference End ("Consent Term"), Presenter grants to ASPB, its assigns, licensees and successors the right to broadcast, display, reproduce, translate, modify, edit or otherwise use Presenter's image, likeness, name, biographical information, actions, voice, conversations and material spoken or otherwise provided to ASPB or presented by Presenter during the Presentation (including Presentation slides, poster and materials) as captured in the video and audio recordings prepared by or submitted to ASPB ("Materials") for access by conference registrants during the conference dates and on-demand for the duration of the Consent Term. ASPB will not resell or otherwise use the Materials for any other purpose without Presenter's written consent. Posters can be removed from the gallery by the Presenter at any time after the Conference Dates using the poster upload task. Otherwise, the Poster will be available for the Consent Term. After the Consent Term, Presenter acknowledges and agrees that ASPB may continue use of the Materials for internal and archival purposes.

2. Ownership. The parties acknowledge and agree that all recordings will be the property of ASPB; however the Presenter shall retain ownership of all scientific and intellectual content.



3. Representations and Warranties. Presenter represents and warrants that: (1) Presenter has the authority to grant the rights granted under this Agreement; (2) Presenter has obtained all required permission or copyright clearances necessary for ASPB's use of any third-party material as they may appear in the Presentation, and (3) neither the Presentation nor its use in the Materials as contemplated under this Agreement will infringe upon or violate any rights of any third party.

4. Indemnification. Presenter agrees to indemnify and hold ASPB and its directors, officers, employees, agents, and members harmless with respect to any and all claims, losses, damages, liabilities, judgments, or settlements, including reasonable attorney's fees, costs, and other expenses incurred by ASPB on account of any breaches of Presenter's representations and warranties in Section 3. The rights and responsibilities established in this paragraph shall survive indefinitely the termination of this Agreement.

5. Choice of Law/Jurisdiction. The construction, validity and performance of this Agreement shall be governed by, and construed in accordance with, the laws of the State of Maryland, and the parties expressly waive its choice of law rules. The parties agree that venue and jurisdiction for any controversy or litigation arising out of, related to, or regarding the validity of, this Agreement shall lie in the state or federal courts serving Montgomery County, Maryland.

6. Counterparts. This Agreement may be executed in counterparts, and electronic signatures shall be deemed original for all purposes. This document is admissible in any proceeding to interpret or enforce this Agreement.
