Research Abstract and Clinical Conundrums Instructions and Guidelines

We are pleased to provide these Instructions and Guidelines for those submitting Research Abstracts and/or Clinical Conundrums for presentation at the Pediatric Hospital Medicine 2023 (PHM23) Conference. PHM23 will be held as a live, in-person event, August 3-6, 2023.

A standardized, blinded review process will be utilized for the selection of Research Abstracts and Clinical Conundrums. High-scoring submissions may be eligible for oral/platform presentation or E-Poster presentations.

Research Abstracts and Clinical Conundrums Important Information

Submitter Information

- Lead Authors should only submit their work if they can be present during the live, in-person conference dates of August 3-6, 2023.
- PHM23 staff will only communicate with the lead author/presenter. Please ensure all information submitted for the lead author is accurate.
- Lead authors/presenters are responsible for collecting and communicating information to coauthors/presenters.
- If a submission is accepted for presentation, at least one lead author(s)/presenter(s) must register for PHM23 in order to present their work.
- All lead authors/presenters are required to provide contact information for their submission.
- All lead authors/presenters are required to provide financial relationship disclosure information.
- Lead authors/presenters have the option to complete contact and financial disclosure information on behalf of their co-authors/presenters.
- All lead authors/presenters will be required to finalize the submission once all information is collected.

Review and Notification Information

- The scheduling of presentations will take place after final selections and submitters will be notified of their selection status.
- Review and selection of Research Abstracts and Clinical Conundrums will take place March 2023.
- Acceptance notifications will be sent to lead authors in April 2023.
- The PHM23 Planning Committee will determine how accepted presentations will be delivered either oral presentation or E-Poster presentation. Presentation format will be communicated in the acceptance notifications.
- If you are selected to present your work at PHM23, keep in mind that your presentation could be scheduled throughout the duration of the conference, August 3-6, 2023.

- Submissions are limited to 2,600 characters (including spaces) or less (not including abstract title). It is strongly recommended that you draft your Research Abstract using Word or a similar product and then copy and paste the text into the online system. (This will help to ensure your submission does not exceed the character limit).
- Research Abstracts must be submitted in one of the following three categories*:
 - Clinical and Health Services Research
 - o Medical Education
 - Quality Improvement
 - *Note: Abstracts that do not necessarily fit into one of the three categories are welcome however, you must select one of the three categories in order to complete your submission.
- Submissions are required to include the following:
 - o Title
 - o Introduction
 - o Objective
 - $\circ \quad \text{Methods} \quad$
 - o Results
 - Discussion/Conclusion
- One supplemental PDF file containing a maximum of one table or figure pertinent to the submission may be uploaded. A supplemental table or figure is optional and not required with your submission.
- Research Abstracts can be edited until the point of final submission. Research Abstracts cannot be edited following final submission.
- Research Abstracts can be presented at other meetings, but not accepted for publication at the time of submission.
- Works in progress (without complete results), topics without relevance to Pediatric Hospital Medicine, and case reports will not be accepted as Research Abstracts.

Guidelines for Research Abstract Submissions

- The individual creating the system account and entering the Research Abstract information will be considered the lead author and sole Research Abstract presenter at PHM23, if selected for presentation.
- Please enter all other co-authors in the order in which they should appear in the heading of the Research Abstract.
- Lead authors can complete contact information as well as financial disclosure information for all co-authors. Lead authors may also choose to invite co-authors to the system to complete their information and financial disclosures.
- All aspects of your submission author information, disclosure information, Research Abstract body information must be completed for final submission to occur.
- When submission is completed, the lead author will receive a confirmation e-mail.

Please use the following guidelines to help determine in which category your Research Abstract should be submitted:

Clinical and Health Services Research

Reviewers will be looking for:

- Patient-, provider-, practice-, hospital-, or systems-level outcomes
- Focus on diagnosis and management of diseases, or aspects of health services delivery

Medical Education Research

Reviewers will be looking for:

- Study of the impact of teaching, development of educational materials, curriculum development, or evaluation development.
- Measurable outcomes (may be qualitative)

Quality Improvement

Reviewers will be looking for:

- Data over time
- Run chart
- Multiple PDSA cycles- data is used to influence subsequent interventions
- Sufficient detail about setting, personnel, and resources to understand context

Please include the following information in the sections of the body of your Research Abstract of the PDF:

- <u>Title</u>: provide a title for your Research Abstract. This field has a 75-word / 200-character limit. This word/character count is separate and not included in the overall character count for your Research Abstract.
- <u>Introduction</u>: provide a brief introduction to your research.
- <u>Objective</u>: provide a clear and specific description of the overall purpose of your study.
- <u>Methods</u>: provide a description of the research design and analytic approach.
- <u>Results</u>: provide a description of the study population, sample size, and major findings.
- <u>Discussion/Conclusion</u>: provide a brief summary of your conclusions and the implications of your work.

Please <u>DO NOT</u> identify yourself, your co-authors or your institution anywhere in the body of your **Research Abstract submission**. Your submission will be blinded for review and should not include any identifying information.

File uploads

You may include one *optional* PDF file upload with your submission.

- Your PDF file may include a maximum of 1 Table or Figure.
- Eliminate all white space around images.
- Captions must be included as part of your image/table/graph.
- All text within the image should be large enough so that it is readable when the images is printed or viewed on screen.
- Complex images are not recommended as they may be difficult for the reader to see an adequate level of detail.
- Your upload file name cannot contain spaces or special characters; it must have standard alphanumeric characters only.

- Works in progress (without final conclusive diagnosis) and topics without relevance to Pediatric Hospital Medicine will not be accepted as Clinical Conundrums.

Guidelines for Clinical Conundrum Submissions

- The individual creating the system account and entering the Clinical Conundrum information will be considered the lead author and sole Clinical Conundrum presenter at PHM23.
- Only one person may present a Clinical Conundrum, although others may be listed as coauthors.
- Please enter all other co-authors in the order in which they should appear in the heading of the Clinical Conundrum.
- Lead authors can complete contact information as well as financial disclosure information for all co- authors. Lead authors may also choose to invite co-authors to the system to complete their information and financial disclosures.
- All aspects of your submission author information, disclosure information, Clinical Conundrum body information must be completed for final submission to occur.
- When submission is completed, the lead author will receive a confirmation e-mail.
- Please submit your Clinical Conundrum in one of the following categories:

Please include the following information in the sections of the body of your Clinical Conundrum:

- <u>Title</u>: provide a compelling title for your Clinical Conundrum. This field has a 75-word / 200character limit. This word/character count is separate and not included in the overall character count for your Clinical Conundrum.
 - Please do not include the final diagnosis (or significant clue) in the title.
- <u>Initial History/Presentation</u>: provide information about the initial history taken or the presentation of the patient when first seen.
- <u>Physical Exam</u>: provide information about the physical exam conducted relevant to your Clinical Conundrum.
- <u>Diagnostic Evaluation</u>: provide the result of any tests, procedures, or imaging conducted on the patient.
- <u>Diagnosis</u>: provide a description of the diagnosis made as a result of your exam and evaluation.
- <u>Discussion/Conclusion</u>: provide a brief summary of your interpretations and conclusions.

Please DO NOT identify yourself, your co-authors or your institution anywhere in the body of your **Clinical Conundrum submission**. Your submission will be blinded for review and should not include any identifying information.

File uploads

- You may include one PDF file upload for your submission.
- Your PDF file may include images, tables, graphs.
- Your uploaded file should include only information pertinent to your Clinical Conundrum and should be limited to a maximum of three images/tables/graphs.
- Eliminate all white space around images.
- Captions must be included as part of your image/table/graph.
- All text within the image should be large enough so that it is readable when the images is printed or viewed on screen.
- Complex images are not recommended as they may be difficult for the reader to see an adequate level of detail.
- Your upload file name should not contain spaces or special characters; it must have standard alphanumeric characters only.
