

Speaker Agreement - Concurrent Paper Sessions

Thank you for agreeing to present your work and research as part of the APT Seattle 2023 Conference. Please read this agreement carefully as it pertains to requirements for presenting at the conference, fulfilling Continuing Education credit program requirements, Media Consent and Waiver, and Publication Release for online publication of your image and your work.

General Requirements

Speakers must sign and return this agreement by the deadline presented in the acceptance notification. In addition, speakers shall:

- 1. Cooperate fully with the conference planners, session chair and other speakers in their assigned session to develop a cohesive, logical, and organized group of presentations.
- 2. Meet deadlines for submissions (group or individual) indicated in acceptance, including participation in any organizing meetings or discussions arranged by the session chair to meet those deadlines.
- 3. Register for the conference by the close of early registration at the speaker rate. This registration is non-refundable. In the event that a speaker cannot fulfill this agreement, notify the session chair immediately, indicating the reason. Speakers have the option of transferring their registration to a designated alternate speaker. APT shall have final approval of alternate speakers.
- 4. Failure to fulfill the requirements of the agreement may result in APT rescinding acceptance and refusal to consider future abstracts submitted by the speaker.

Continuing Education Reporting Agency Requirements

APT is a registered American Institute of Architects (AIA) and a Registered Continuing Education Program (RCEP) continuing education provider. As a condition of offering credits, all conference speakers and facilitators (as participants in providing continuing education) must review and sign the speaker agreement. Your presentation is part of a coordinated event submitted for review by AIA and RCEP well in advance of the conference.
